3. 2021 Financial Reports: to the end of August 2021

- looking at the balance sheet, the Small Grants Program funds are clearly identified (see *Other current assets*). Net of these funds, we have approximately \$74,000 of which \$17,000 comes from Rosina Horeth's legacy for the Beyond initiative, leaving \$57,000 as our core funds.
- looking at the profit and loss: our donations received for the year to date are below budget, but overall our revenues are above budget for the year so far if we include money owed by some regions. It was agreed to request donations for fee support as usual this fall/autumn.
- Office equipment includes a new laptop for the Office Manager, the first for many years.
- Overall, we have a small net balance, despite unbudgeted costs. Also, we have not yet drawn down OP funds to cover OP costs this can be done at the end of the year.

4. Executive Director's report, August 2021

• We have reverted to our annual zoom subscription, and there is less demand for additional zoom services as the pandemic situation continues to change.

- Arjun has recently updated with the Beyond initiative dance leaders, by zoom.
- <u>LG fee collection and reminders</u> going well: thank you, Martha! There is no indication that the pandemic is affecting LG numbers as yet, and new leaders are still joining in several countries.
- <u>copyright infringement</u>: we have sought legal help to ensure that our copyright and trademark registrations are current; we continue to work to resolve two cases of copyright infringement concerning the DUP logo.
- <u>newsletters</u> were circulated in May and June.

Facebook

The Facebook group is still attracting new members after a few quiet weeks in the northern summer.

5. Small Grants Program

Following the April BoD meeting, the Board approved

- a transitional grants cycle for international applications referred to us from Oneness Project, followed by an initial grants cycle in the second half of 2021
- the release of \$10,000 from funds which may be disbursed on small grants between April and the end of September 2021;
- the criteria for the award of small grants as set out on the website in each language eg here in English.

The first full cycle of awards has been made, to applicants across 10 countries, within the above budget. Some awards for face to face events are awaiting local improvements in the pandemic situation.

The review committee and database processes worked well.

The Board has approved the release of \$10,000 for cycle 2 in 2022. Details will be advertised at the turn of the year.

6. Beyond Initiative plans for 2022

Plans for the Beyond initiative in 2022 include a dance leader training event at Atlantida, Colombia, at Easter 2022 and a dance leader training event in Istanbul later in the year, maybe also other events in the Middle East.

The Board approved release of \$5,000 from legacy funds for the Beyond initiative to support young dance leaders in attending a dance leader training in Atlantida, Colombia from April 10 to 17, 2022.

These support funds will be managed by Arjun, and will be available for dance leaders from the Middle East and Asia who have already committed to dance leader training as part of the Beyond initiative, who can demonstrate that they have maintained their connection to the dances during the last two years. Leaders will be expected to make a contribution to their costs of attendance. Grants will be for contributions to travel costs and seminar costs.
