Comments from the board

Arising issues

Deciding when to stop translating to 7 languages.

Involving the regions in translation, encourage regions to check the browser translations to overview quality.

Vakil. Involving regions is necessary but requires planning time/resources.

Douglas. We need strategies for engagement into the social network aspect.

Munira. It seems that we need more people to be involved in as part of a strategy.

Arjun. Be clear on what are the "regions" we want to connect. Why people comes to the platform: To

publish events and explore dances. Let's be sure these two products are working fine.

Next steps.

Lets try the platform as a board creating a space for us. Vakil to create a tutorial for board engagement and mentor/mentee relation using the platform.

Create a strategy to involve regions. Explain the region's advantages to use the system.

Create a strategy to have the complete list of events into the platform.
